## **APPROPRIATION ORDINANCE NO. 06-2025**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SEVENTY- FOUR THOUSAND PESOS (P74,000.00) FROM THE APPROPRIATION FOR TELEPHONE EXPENSES – MOBILE, OTHER MOOE, POSTAGE AND DELIVERIES, PRINTING & BINDING EXPENSES, REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND REPAIR & MAINTENANCE – IT EQUIPMENT & SOFTWARE UNDER THE OFFICE OF THE MUNICIPAL CIVIL REGISTRAR TO OTHER SUPPLIES EXPENSES AND TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for TELEPHONE EXPENSES – MOBILE, OTHER MOOE, POSTAGE AND DELIVERIES, PRINTING & BINDING EXPENSES, REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND REPAIR & MAINTENANCE – IT EQUIPMENT & SOFTWARE under the office of the Municipal Civil Registrar, San Pablo, Zamboanga del Sur;

Section 2. The TOTAL AMOUNT OF SEVENTY- FOUR THOUSAND PESOS (P74,000.00) shall be transferred to wit:

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
