APPROPRIATION ORDINANCE NO. 07-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE MILLION SIXTY-NINE THOUSAND NINE HUNDRED SIXTY - EIGHT PESOS AND FIFTEEN CENTAVOS (P1,069,968.15) FROM THE APPROPRIATION FOR REPAIR OF THE FOLLOWING: BIRTHING WARD; BAHAY NI NANAY; RHU BUILDING (CEILING AND FLOORING); MHO GRILLS; RHU RAMP; AND IMPROVEMENT / REHABILITATION OF RHU; AND CONSTRUCTION OF GARAGE FOR MHO UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO REPAIR AND IMPROVEMENT OF RURAL HEALTH UNIT (RHU) BIRTHING FACILITY OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for REPAIR OF THE FOLLOWING:

(CEILING AND FLOORING); MHO GRILLS; RHU RAMP;
IMPROVEMENT /REHABILITATION OF RHU; AND
CONSTRUCTION OF GARAGE FOR MHO under the office of the
Municipal Health Officer, San Pablo, Zamboanga del Sur, previous
years unimplemented budget;
