APPROPRIATION ORDINANCE NO. 08-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SEVEN HUNDRED SIXTY NINE THOUSAND NINE HUNDRED SIXTY - EIGHT PESOS AND FIFTEEN CENTAVOS (P769,968.15) FROM THE APPROPRIATION FOR REPAIR OF THE FOLLOWING; BAHAY NI NANAY; RHU BUILDING (CEILING AND FLOORING); MHO GRILLS; RHU RAMP; AND IMPROVEMENT /REHABILITATION OF RHU; AND CONSTRUCTION OF GARAGE FOR MHO UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO REPAIR OF BIRTHING WARD/ FACILITY OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR OF THE FOLLOWING: BAHAY NI NANAY; RHU BUILDING (CEILING AND FLOORING); MHO GRILLS; RHU RAMP; IMPROVEMENT /REHABILITATION OF RHU; AND CONSTRUCTION OF GARAGE FOR MHO** under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur, previous years unimplemented budget;

Section 2. The **TOTAL AMOUNT OF SEVEN HUNDRED SIXTY NINE THOUSAND NINE HUNDRED SIXTY - EIGHT PESOS AND FIFTEEN CENTAVOS (P769,968.15)** shall be realigned to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
