APPROPRIATION ORDINANCE NO. 18-2025

"AN ORDINANCE TRANSFERRING THE TOTAL AMOUNT OF THREE MILLION FOUR HUNDRED NINETY- EIGHT THOUSAND TWO HUNDRED FIFTY- FIVE PESOS (P3,498,255.00) FROM THE DIFFERENT IDENTIFIED PROGRAMS IN THE 2025 ANNUAL BUDGET (NON-OFFICE EXPENDITURES): SOLID WASTE; COASTAL RESOURCE MANAGEMENT (CRM); PEACE AND ORDER AND BARANGAY ROAD REHABILITATION PROGRAM TO GENERAL SERVICES UNDER THE OFFICE OF THE MUNICIPAL MAYOR, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for FROM THE DIFFERENT IDENTIFIED PROGRAMS IN THE 2025 ANNUAL BUDGET (NON-OFFICE EXPENDITURES): SOLID WASTE; COASTAL RESOURCE MANAGEMENT (CRM); PEACE AND ORDER AND BARANGAY ROAD REHABILITATION PROGRAM (NON-OFFICE EXPENDITURES) of the municipality of San Pablo, Zamboanga del Sur;

Section 2. The total amount of THREE MILLION FOUR HUNDRED NINETY EIGHT THOUSAND TWO HUNDRED FIFTY- FIVE PESOS (P3,498,255.00) shall be transferred to the General Services Account under the Office of the Municipal Mayor, to wit:
