## **APPROPRIATION ORDINANCE NO. 19-2025**

"AN ORDINANCE APPROPRIATING THE TOTAL AMOUNT OF EIGHT HUNDRED THOUSAND PESOS (P800,000.00) FROM TOTAL ADDITIONAL REALIZED INCOME OF THE GENERAL FUND FOR CY 2024 FOR PAYMENT OF BIR REMITTANCE AND OTHER EXPENSES OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. Title of Appropriation: This appropriation ordinance shall be entitled: 2024 Additional Realized Income of the General Fund of the municipality of San Pablo, Zamboanga del Sur;
- **Section 2. Sources of Appropriation**: The Municipal Accountant, the Municipal Treasurer and the Municipal Mayor certified availability of funds per joint certification dated September 15, 2025.
- Section 3. The total amount of Eight Hundred Thousand Pesos (P800,000.00) shall be used for the following:

Overtime pay (MTO)	P50,000.00
Overtime pay (MACO)	15,000.00
Monetization:	
a. Santos Saysis	30,000.00
b. Allan Borda	30,000.00
Travel (MACO)	100,000.00
Other Supplies (MTO)	30,000.00
Remittance for BIR	200,000.00
Relocation Cost with UB of Vee Phase Primary Line	150,000.00
Sports Development	100,000.00
Waterworks Billing Statement	95,000.00
TOTAL	P800,000.00

- **Section 4.** Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
- **Section 5.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
