EXCERPT FROM THE MINUTES OF THE 13<sup>TH</sup> REGULAR SESSION OF THE 12<sup>TH</sup> SANGGUNIAN BAYAN MEMBERS OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE MULTI-PURPOSE BUILDING, ON OCTOBER 20, 2025.

**APPROPRIATION ORDINANCE NO. 33-2025**

**"AN ORDINANCE AUTHORIZING THE TOTAL AMOUNT OF FORTY-TWO THOUSAND PESOS (42,000.00) FROM THE APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES (OMOOE) UNDER THE OFFICE OF THE SANGGUNIAN BAYAN, SAN PABLO, ZAMBOANGA DEL SUR, FOR PAYMENT OF HONORARIUM FOR THE FOURTEEN (14) TRAINERS WHO WILL TRAIN THE ATHLETES IN BOTH ELEMENTARY AND SECONDARY LEVELS FOR UPCOMING QUALCI MEET."**

**BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for **OTHER MAINTENANCE AND OPERATING EXPENSES (OMOOE)** under the office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur, for CY 2025, in the total amount of **FORTY-TWO THOUSAND PESOS (P42,000.00)**;

**Section 2.** The **total amount of Forty-Two Thousand Pesos (P42,000.00)** shall be used for payment of Honorarium for the Fourteen (14) Trainers who will train the Athletes in both Elementary and Secondary levels for the upcoming QUALCI Meet on November 8-9, 2025.

**Section 3.** Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.

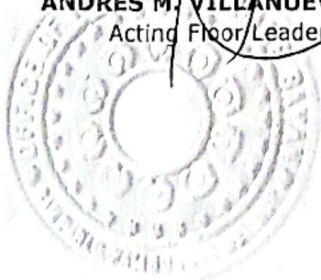
**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
