APPROPRIATION ORDINANCE NO. 37-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED THIRTY-THREE THOUSAND NINE HUNDRED PESOS (P133,900.00) FROM THE APPROPRIATION FOR ACCOUNTABLE FORMS EXPENSES, OFFICE SUPPLIES EXPENSES, TELEPHONE EXPENSES, PRINTING AND BINDING EXPENSES, FEDELITY BOND PREMIUMS, REPAIR & MAINTENANCE - OFFICE EQUIPMENT AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL TREASURER, SAN PABLO, ZAMBOANGA DEL SUR TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **ACCOUNTABLE FORMS EXPENSES, OFFICE SUPPLIES EXPENSES, TELEPHONE EXPENSES PRINTING AND BINDING EXPENSES, FEDELITY BOND PREMIUMS, REPAIR & MAINTENANCE - OFFICE EQUIPMENT AND OTHER MOOE** under the office of the Municipal Treasurer, San Pablo, Zamboanga del Sur;

Section 2. The **ONE HUNDRED THIRTY-THREE THOUSAND NINE HUNDRED PESOS (P133,900.00)** shall be transferred/augmented as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
