APPROPRIATION ORDINANCE NO. 38-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY-FOUR THOUSAND PESOS (P54,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES EXPENSES, TELEPHONE EXPENSES, MEMBERSHIP DUES & CONTRIBUTION TO ORGANIZATIONS, PRINTING AND BINDING EXPENSES, REPAIR & MAINTENANCE - OFFICE EQUIPMENT, REPAIR & MAINTENANCE-IT EQUIPMENT AND OTHER MOE UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER, SAN PABLO, ZAMBOANGA DEL SUR TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OFFICE SUPPLIES EXPENSES, TELEPHONE EXPENSES, MEMBERSHIP DUES & CONTRIBUTION TO ORGANIZATIONS, PRINTING AND BINDING EXPENSES, REPAIR & MAINTENANCE - OFFICE EQUIPMENT, REPAIR & MAINTENANCE-IT EQUIPMENT AND OTHER MOE** under the office of the Municipal Budget Officer, San Pablo, Zamboanga del Sur;

Section 2. The **FIFTY-FOUR THOUSAND PESOS (P54,000.00)** shall be transferred/augmented as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
