APPROPRIATION ORDINANCE NO. 392025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTYSEVEN THOUSAND TWO HUNDRED FIFTY PESOS (P27,250.00) FROM THE
APPROPRIATION FOR TELEPHONE EXPENSES, PRINTING AND BINDING
EXPENSES, REPAIR & MAINTENANCE-IT EQUIPMENT AND OFFICE SUPPLIES
EXPENSES UNDER THE OFFICE OF THE DEPARTMENT OF INTERIOR AND LOCAL
GOVERNMENT (DILG), SAN PABLO, ZAMBOANGA DEL SUR TO OTHER SUPPLIES
EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for TELEPHONE EXPENSES, PRINTING AND BINDING EXPENSES, REPAIR & MAINTENANCE-IT EQUIPMENT AND OFFICE SUPPLIES EXPENSES under the office of the DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG), San Pablo, Zamboanga del Sur;

Section 2. The TWENTY-SEVEN THOUSAND TWO HUNDRED FIFTY PESOS (P27,250.00)) shall be transferred/augmented as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
