APPROPRIATION ORDINANCE NO. 40-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO HUNDRED TWENTY-ONE THOUSAND PESOS (P221,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES EXPENSES, OTHER SUPPLIES, INTERNET EXPENSES, MEMBERSHIP DUES TO ORGANIZATIONS, PRINTING & BINDING EXPENSES, REPAIR & MAINTENANCE MOTOR VEHICLE AND INSURANCE EXPENSES UNDER THE OFFICE OF THE SANGGUNIAN BAYAN, SAN PABLO, ZAMBOANGA DEL SUR TO OTHER MOOE OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OFFICE SUPPLIES EXPENSES, OTHER SUPPLIES, INTERNET EXPENSES, MEMBERSHIP DUES TO ORGANIZATIONS, PRINTING & BINDING EXPENSES, REPAIR & MAINTENANCE MOTOR VEHICLE AND INSURANCE EXPENSES** under the office of the **Sangguniang Bayan, San Pablo, Zamboanga del Sur;**

Section 2. The **TWO HUNDRED TWENTY-ONE THOUSAND PESOS (P221,000.00)** shall be transferred/augmented as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
