**APPROPRIATION ORDINANCE NO. 42-2025**

**"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY-SIX THOUSAND ONE HUNDRED PESOS (P26,100.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES EXPENSES, REPAIR & MAINTENANCE IT EQUIPMENT, DRUGS AND MEDICINES, INSTALLATION OF GLASS DOORS & WINDOWS, AND GASOLINE OIL & LUBRICANTS UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER, SAN PABLO, ZAMBOANGA DEL SUR TO OTHER MOOE, SPECIAL PROGRAMS/WAH, AND REPAIR AND MAINTENANCE AMBULANCE AND SAKYANAN NI NANAY OF THE SAME OFFICE."**

**BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for **OFFICE SUPPLIES EXPENSES, REPAIR & MAINTENANCE IT EQUIPMENT, DRUGS AND MEDICINES, INSTALLATION OF GLASS DOORS & WINDOWS, AND GASOLINE OIL & LUBRICANTS** under the office of the **Sangguniang Bayan, San Pablo, Zamboanga del Sur;**

**Section 2.** The total amount of **TWENTY-SIX THOUSAND ONE HUNDRED PESOS (P26,100.00)** shall be transferred/augmented as follows:

**Section 3.** Transfer/Augment of Item. **Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
