APPROPRIATION ORDINANCE NO. 42-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY-SIX THOUSAND ONE HUNDRED PESOS (P26,100.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES EXPENSES, REPAIR & MAINTENANCE IT EQUIPMENT, DRUGS AND MEDICINES, INSTALLATION OF GLASS DOORS & WINDOWS, AND GASOLINE OIL & LUBRICANTS UNDER THE OFFICE OF THE MUNICIPAL HEALTHE OFFICER, SAN PABLO, ZAMBOANGA DEL SUR TO OTHER MOOE, SPECIAL PROGRAMS/WAH, AND REPAIR AND MAINTENANCE AMBULANCE AND SAKYANAN NI NANAY OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for OFFICE SUPPLIES EXPENSES, REPAIR & MAINTENANCE IT EQUIPMENT, DRUGS AND MEDICINES, INSTALLATION OF GLASS DOORS & WINDOWS, AND GASOLINE OIL & LUBRICANTS under the office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur;

Section 2. The total amount of TWENTY-SIX THOUSAND ONE HUNDRED PESOS (P26,100.00) shall be transferred/augmented as follows:

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
