**APPROPRIATION ORDINANCE NO. 43-2025**

**"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF EIGHTY-THREE THOUSAND PESOS (P83,000.00) FROM THE APPROPRIATION FOR OTHER MOOE, REPAIR & MAINTENANCE – IT EQUIPMENT, TRAVELLING EXPENSES, REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND TELEPHONE EXPENSES UNDER THE OFFICE OF THE WATERWORKS, SAN PABLO, ZAMBOANGA DEL SUR TO OTHER SUPPLIES EXPENSES OF THE SAME OFFICE."**

**BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:**

**Section 1.** There is an appropriation for **OTHER MOOE, REPAIR & MAINTENANCE – IT EQUIPMENT, TRAVELLING EXPENSES, REPAIR & MAINTENANCE – OFFICE EQUIPMENT AND TELEPHONE EXPENSES** under the office of the **Waterworks**, San Pablo, Zamboanga del Sur;

**Section 2.** The total amount of **EIGHTY-THREE THOUSAND PESOS (P83,000.00)** shall be transferred/augmented as follows:

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
