RESOLUTION NO. 2025-20

"A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. DIVINE NELEH A. TAUCAN-ANGHAD OF SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF THE REGISTRY SYSTEM FOR BASIC SECTOR IN AGRICULTURE PROFILING PLATFORM FOR LOCAL GOVERNMENT UNITS (RSBSAPP-LGU)."

WHEREAS; the Department of Agriculture (DA) is implementing the Registry System for Basic Sectors in Agriculture (RSBSA) as a nationwide database and profiling system for farmers, fisherfolk and other agricultural stakeholders to support targeted assistance and agricultural development programs;

WHEREAS, the Registry System for Basic Sectors in Agriculture Profiling Platform for Local Government Units (RSBSAPP-LGU) is an upgraded platform designed to enhance local government participation in data gathering, updating, and validation of agricultural sectors profiles;

WHEREAS, the participation of the Local Government Unit (LGU) is essential in ensuring the accuracy, and regular updating of the registry data, which will serve as vital tool for planning, implementing, and monitoring agriculture-related programs and interventions;

WHEREAS, the Department of Agriculture requires the execution of a Memorandum of Agreement (MOA) between the DA and the LGU to formally establish cooperation and delineate the roles and responsibilities of both parties in the implementation of the RSBSAPP-LGU;

WHEREAS, it is deemed proper and necessary to authorize the Local Chief Executive (LCE) to represent the LGU and sign the said MOA on its behalf.

WHEREFORE, on motion by Hon. Glid B. Binag, severally seconded, be it

RESOLVED, as it is hereby resolved, AUTHORIZING THE MUNICIPAL MAYOR, HON. DIVINE NELEH A. TAUCAN-ANGHAD OF SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE FOR THE IMPLEMENTATION OF THE REGISTRY SYSTEM FOR BASIC SECTOR IN AGRICULTURE PROFILING PLATFORM FOR LOCAL GOVERNMENT UNITS (RSBSAPP-LGU).
