## **RESOLUTION NO. 2025-24**

"A RESOLUTION EXTENDING THE PERIOD FOR THE SUSPENSION OF THE IMPLEMENTATION AND/OR ENFORCEMENT OF THE MUNICIPAL ORDINANCE NO. 4, SERIES OF 2000, AS EMBODIED IN RESOLUTION NO. 2025 DATED 11 AUGUST 2025, AND HEREBY EXTENDED UNTIL DECEMBER 31, 2025."

**WHEREAS,** on August 11, 2025 this august body had approved Resolution No. 2025-13, which suspended the implementation and enforcement of Municipal Ordinance No. 4, Series of 2000 within the period from August 1, 2025 to September 30, 2025;

**WHEREAS,** the above- extended period is about to expire on September 30, 2025, and the desired revision of the said ordinance has not yet been finalized;

**WHEREAS,** in order to give ample time to the committee which is in-charge in the preparation and promulgation of the said ordinance, it is but proper and appropriate that this august body shall extend effectivity of the suspension of the implementation and enforcement of the said ordinance, instead of September 30, 2025, it shall be extended until December 31 2025.

**NOW, THEREFORE,** on motion of Hon. Esmael M. Abellanosa, severally seconded, be it,

RESOLVED, as it hereby resolved, EXTENDING THE PERIOD FOR THE SUSPENSION OF THE IMPLEMENTATION AND/OR ENFORCEMENT OF THE MUNICIPAL ORDINANCE NO. 4, SERIES OF 2000, AS EMBODIED IN RESOLUTION NO. 2025 DATED 11 AUGUST 2025, AND HEREBY EXTENDED UNTIL DECEMBER 31, 2025.
