RESOLUTION NO. 2025-37

"A RESOLUTION URGENTLY REQUESTING FOR FINANCIAL ALLOCATION FOR BUDGET FROM REGIONAL DIRECTOR AND/OR PROVINCIAL DIRECTOR OF THE NATIONAL IRRIGATION ADMINISTRATION (NIA), PAGADIAN CITY FOR THE CONSTRUCTION AND/OR REPAIR OF IRRIGATION CANAL, LOCATED AT POBLACIÓN TO MARCOS VILLAGE, SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS; this August Body had received a request from the farmers of Barangay Poblacion and Marcos Village, both in San Pablo, Zamboanga del Sur for the construction of irrigation canal, situated at Barangay Marcos Village, San Pablo, Zamboanga del Sur, and/or repair of the existing irrigation canal at Barangay Poblacion, San Pablo, Zamboanga del Sur;

WHEREAS, upon verification of the said request, it was found out that indeed there is a need for the construction of an irrigation canal to cater the needs of the farmers on their rice field, situated at barangay Marcos Village and/or for the repair of the existing irrigation canal in Barangay Poblacion, San Pablo, Zamboanga del Sur;

WHEREAS, these irrigation canals, if granted, would greatly increase the harvest of palay for the said farmers, as the water supply would be adequate enough to their respective rice fields;

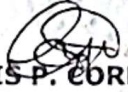
WHEREFORE, on motion by Hon. Dennis P. Cordero, severally seconded, be it
