RESOLUTION NO. 2025-39

"A RESOLUTION AUTHORIZING THE HON. MUNICIPAL MAYOR, DIVINE NELEH TAUCAN-ANGHAD OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR TO ENTER INTO SPECIFIC IMPLEMENTATION AGREEMENT (SIA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, the Department of Social Welfare and Development (DSWD) implements the Sustainable Livelihood Program (SLP), a capacity-building initiative that aims to improve the socio-economic conditions of poor, vulnerable, and marginalized households and communities;

WHEREAS, the program seeks to enhance the capabilities of participants by providing access to livelihood opportunities and resources that promote sustainable income and employment;

WHEREAS, to effectively implement the said program at the local level, a Specific Implementation Agreement (SIA) is required to be entered into between the DSWD and the Local Government Unit (LGU);

WHEREAS, the partnership will ensure a collaboration effort in the identification of beneficiaries, provision of resources, and monitoring of project outcomes for the Sustainable Livelihood Program within the municipality;

WHEREAS, it is deemed necessary and appropriate to authorize the Local Chief Executive (LCE) to enter into and sign the said agreement on behalf of the Municipality of San Pablo, Zamboanga del Sur.

WHEREFORE, on motion by Hon. Danilo A. Taucan, severally seconded, be it
