RESOLUTION NO. 2025-40

"A RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF THE CIVIL SOCIETY ORGANIZATIONS IN THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, Section 34 of the Local Government Code of 1991 states that the Local Government Units shall promote the establishment and operation of People's and Non-Governmental Organizations to become active partners in the pursuit of local autonomy;

WHEREAS, on July 14, 2022, the Department of the Interior and Local Government issued Memorandum Circular No. 2022-083, on the Guidelines on the Accreditation of Civil Society Organizations and Selection of Representative to the Local Special Bodies;
