"A RESOLUTION ATHORIZING THE MUNICIPAL MAYOR, HONORABLE DIVINE NELEH A. TAUCAN-ANGHAD TO APPLY AND AVAIL THE INDIAN GRANT ASSISTANCE FOR IMPLEMENTATION OF QUICK IMPACT PROJECTS (I-QIP) IN THE AMOUNT OF FIFTY THOUSAND DOLLARS AND TO SUBMIT PROPOSALS FOR INFRASTRUCTURE PROJECTS ON ANY OF THE FOLLOWING SECTOR, TO WIT: AGRICULTURE AND FISHERES, COMMUNITY FACILITIES, DISASTER RISK AND REDUCTION MANAGEMENT, ENVIRONMENTAL MANAGEMENT, HEALTHCARE, MOBILITY AND CONNECTIVITY AND WATER SANNITATION AND HYGIENE (WASH) AND TO SIGN THE INDIVIDUAL PROJECT AGREEMENT AND ALL OTHER PERTINENT DOCUMENTS IN RELATION THERETO FOR AND IN BEHALF OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN PABLO, ZAMBOANGA DEL SUR."

WHEREAS, this August Body received a request from the Office of the Municipal Mayor, DIVINE NELEH A. TAUCAN-ANGHAD, for the passage of a resolution authorizing her to apply and avail the Indian Grant Assistant in the amount of FIFTY THOUSAND DOLLARS (USD 50,000) for the different infrastructure projects and for her to sign the individual project agreement and all other pertinent documents for and in behalf of the Municipal Local Government Unit of San Pablo, Zamboanga del Sur;

WHEREAS, after thorough discussion and evaluation, this August Body finds the said request to be in order and beneficial to the general welfare of the residents of this Municipality;
