EXCERPT FROM THE MINUTES OF THE 16^{TH} REGULAR SESSION OF THE 12^{TH} MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON NOVEMBER 10, 2025.

RESOLUTION NO. 2025 - 65

"A RESOLUTION ORDERING THE TEMPORARY CLOSURE OF THE SAN PABLO-DINAS NATIONAL COASTAL ROAD, PARTICULARLY THE PORTION LOCATED AT SITIO MANGGAY, MIASIN, SAN PABLO, ZAMBOANGA DEL SUR, DUE TO ITS DAMAGE AND THE IMMINENT DANGER IT POSES TO MOTORISTS, AND URGENTLY REQUESTING THE DPWH ZAMBOANGA DEL SUR 2ND DISTRICT ENGINEERING OFFICE FOR ITS IMMEDIATE REPAIR AND RESTORATION."

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the *Local Government Code of 1991*, mandates every local government unit to exercise powers necessary for the promotion of the general welfare, including measures to ensure the safety, health, and convenience of its inhabitants;

WHEREAS, Section 21 of the same Code authorizes LGUs to temporarily close any street, road, or thoroughfare within their jurisdiction when public safety so requires;

WHEREAS, the San Pablo-Dinas National Coastal Road, particularly the portion situated at Sitio Manggay, Barangay Miasin, San Pablo, has sustained structural damage, road collapse, and subsidence as reported by the Municipal Disaster Risk Reduction and Management Office (MDRRMO) and Municipal Engineer's Office;

WHEREAS, said damaged portion poses grave and imminent danger to motorists, commuters, and residents, and continuous passage thereon could lead to vehicular accidents, injuries, or fatalities;

WHEREAS, the Municipality of San Pablo recognizes its duty to take immediate preventive and protective action in coordination with the DPWH, pursuant to the *General Welfare Clause* and *police power authority* vested by law;

WHEREAS, the MDRRMO has recommended immediate temporary closure of the affected road section and urgent repair action by the DPWH Zamboanga del Sur 2nd District Engineering Office;

NOW THEREFORE, on motion of **HON. DENNIS P. CORDERO**, severally seconded,

BE IT RESOLVED by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, in session duly assembled, THAT:

SECTION 1. TEMPORARY ROAD CLOSURE.

The San Pablo-Dinas National Coastal Road, particularly the portion located at Sitio Manggay, Barangay Miasin, San Pablo, is hereby ordered temporarily closed to all vehicular and pedestrian traffic until declared safe by the DPWH and municipal authorities.

SECTION 2. SAFETY MEASURES.

The MDRRMO, Barangay Miasin, and the PNP San Pablo are directed to:

- 1. Erect warning signs, barricades, and detour notices at both approaches of the affected section;
- 2. Implement traffic rerouting and road safety measures in coordination with the Municipal Engineer's Office;
- 3. Continuously monitor and document the condition of the area; and
- 4. Submit a daily situation report to the Office of the Municipal Mayor and the Sangguniang Bayan.

SECTION 3. REQUEST TO DPWH 2ND DISTRICT ENGINEERING OFFICE.

The Sangguniang Bayan hereby urgently requests the DPWH Zamboanga del Sur 2nd District Engineering Office to:

- Conduct an immediate structural assessment and inspection of the damaged road;
- Undertake emergency repair and restoration works to restore safe passage; and
- 3. Provide updates and technical coordination with the LGU regarding the progress of the works.

SECTION 4. TRANSMITTAL AND COORDINATION.

The Secretary to the Sangguniang Bayan is hereby directed to immediately transmit a copy of this Resolution to the DPWH District Engineer, Zamboanga del Sur 2nd District Engineering Office, Guipos, Zamboanga del Sur, and the DPWH Regional Director, Zamboanga City, Zamboanga del Sur, the Office of Civil Defense, for their information, coordination, and immediate action.

SECTION 5. EFFECTIVITY.

This Resolution shall take effect immediately upon approval and shall remain in force until the DPWH certifies the affected portion safe for passage.

RESOLVED FURTHER, that copies of this Resolution be furnished to the DPWH 2nd District Engineering Office, PNP San Pablo, MDRRMO, and Barangay Miasin for their information and compliance.
