## **RESOLUTION NO. 2025-70**

"A RESOLUTION RESPECTFULLY REQUESTING THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA) PHILIPPINES, THROUGH ITS CHIEF REPRESENTATIVE, MR. TAKEMA SAKAMOTO, TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF SAN PABLO, PROVINCE OF ZAMBOANGA DEL SUR, FOR THE CONSTRUCTION OF A FARM-TO-MARKET ROAD PROJECT."

**WHEREAS**, the Municipality of San Pablo, Province of Zamboanga del Sur, experiences significant challenges in transporting agricultural produce from rural barangays to the market because of inadequate and poor-condition roads;

**WHEREAS**, the Local Government of San Pablo recognizes the urgent necessity of constructing a **Farm-to-Market Road Project** to ensure public safety, enhance agricultural mobility, and foster sustainable economic growth;

**WHEREAS**, the Municipality of San Pablo is a harmonious community composed of **Muslim and Christian** residents who work together for peace, development, and environmental protection;

WHEREAS, the Japan International Cooperation Agency (JICA) has been a reliable and long-time development partner of the Republic of the Philippines, providing support for infrastructure, disaster prevention, and community development programs;

**WHEREAS**, the Municipal Government of San Pablo humbly seeks the financial assistance of JICA Philippines to help implement the said project for the benefit of its citizens, particularly those living in flood-prone areas;

WHEREFORE, on motion of Hon. Danilo A. Taucan, severally seconded be it

RESOLVED, as it is hereby RESOLVED, to respectfully request the Japan International Cooperation Agency (JICA) Philippines, through its Chief Representative Mr. Takema Sakamoto, to extend financial assistance to the Municipal Government of San Pablo, Province of Zamboanga del Sur, for the construction of a Farm-to-Market Road Development within the municipality.
