RESOLUTION NO. 2025 - 71

"A RESOLUTION RESPECTFULLY REQUESTING HIS HIGHNESS SHEIKH AMAD ABDULLAH AL-AHMAD AL-SABAH, PRIME MINISTER OF THE STATE OF KUWAIT, TO EXTEND FINANCIAL ASSISTANCE TO THE MUNICIPAL GOVERNMENT OF SAN PABLO, PROVINCE OF ZAMBOANGA DEL SUR, FOR THE CONSTRUCTION OF A **FARM-TO-MARKET ROAD PROJECT."**

WHEREAS, the Municipality of San Pablo, Province of Zamboanga del Sur, experiences significant challenges in transporting agricultural produce from rural barangays to the market because of inadequate and poor-condition roads;

WHEREAS, the Local Government of San Pablo recognizes the immediate need to construct a Farm-to-Market Road to improve transportation, and promote agricultural productivity;

WHEREAS, the Municipality of San Pablo is home to both Muslim and Christian residents who live in peace, unity, and mutual respect, sharing a common goal of community development and harmony;

WHEREAS, HIS HIGHNESS SHEIKH AMAD ABDULLAH AL-AHMAD AL-SABAH, PRIME MINISTER OF THE STATE OF KUWAIT, has long been known for his leadership in promoting international humanitarian cooperation, charitable initiatives, and development assistance to friendly nations;

WHEREAS, the Municipality of San Pablo humbly seeks the benevolent support of HIS HIGHNESS SHEIKH AMAD ABDULLAH AL-AHMAD AL-SABAH to extend financial assistance for the construction of a Farm-to-Market Road Project that would benefit its residents, strengthen disaster resilience, and uplift local livelihoods;
