## **APPROPRIATION ORDINANCE NO. 01-2024**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO MILLION PESOS (P2,000.000.00) FROM THE APPROPRIATION FOR CONCRETING OF CUEVAS-MABAN RESIDENCE AND INSTALLATION OF CULVERTS FOR MUNICIPAL STREETS TO ADDITIONAL APPROPRIATION FOR LOAN REPAYMENT OF SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for CONCRETING OF CUEVAS-MABAN STREET AND INSTALLATION OF CULVERTS FOR MUNICIPAL STREETS FOR CY 2023;

Section 2. The total amount of TWO MILLION PESOS (P2,000.000.00) shall be transferred to wit:

**Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
