APPROPRIATION ORDINANCE NO. 02-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY THOUSAND PESOS (P20,000.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES EXPENSES AND REPAIR AND MAINTENANCE OF IT EQUIPMENT UNDER THE OFFICE OF THE SANGGUNIANG SECRETARY TO INTERNET EXPENSES CODE 774 OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Other Supplies Expenses and Repair and Maintenance of IT Equipment under the Office of the Sangguniang Secretary, San Pablo, Zamboanga del Sur, for CY 2023;

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sangguniang concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
