APPROPRIATION ORDINANCE NO. 02-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIFTY THOUSAND PESOS (P50,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO INTERNET SERVICE EXPENSES AND OTHER MOOE OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur;

Section 2. The TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P50,000.00) shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
