EXCERPT FROM THE MINUTES OF THE 70TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON MARCH 20, 2024.

APPROPRIATION ORDINANCE NO. 03-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FOUR HUNDRED THOUSAND PESOS (P400,000.00) FROM THE APPROPRIATION FOR GASOLINE, OIL & LUBRICANTS, REPAIR AND MAINTENANCE OF VEHICLES & OTHER MOOE UNDER THE OFFICE OF THE SANGGUNIANG BAYAN TO TRAVELLING EXPENSES AND MAINTENANCE OF LEGISLATIVE SUPPORT SYSTEM OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **GASOLINE, OIL & LUBRICANTS, REPAIR AND MAINTENANCE OF VEHICLES & OTHER MOOE** under the Office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur, for CY 2024;

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
