APPROPRIATION ORDINANCE NO. 04-2022

"AN ORDINANCE TRANSFERRING THE TOTAL AMOUNT OF ONE HUNDRED THIRTY FIVE THOUSAND PESOS (P135,000.00) FROM THE APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES CODE 969 UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, TO REPAIR AND MAINTENANCE OF OFFICE BUILDING CODE NO. 811 OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **OTHER MAINTENANCE AND OPERATING EXPENSES CODE 969** under the office of the Sangguniang Bayan for FY 2022, amounting One hundred Fifty Thousand Pesos (P150,000.00);

Section 2. The total amount of One Hundred Thirty Five Thousand Pesos (P135,000.00) shall be transferred to **REPAIR AND MAINTENANCE OF OFFICE BUILDING CODE NO. 811** of the same office.

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED AND APPROVED on this 3RD day of August, 2022, during the 4TH Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
