**APPROPRIATION ORDINANCE NO. 04-2023**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

**Section 1.** This Appropriation Ordinance shall be entitled "***PS Savings of various vacant positions for the month of January and February, 2023.***"

**Section 2.** Sources of appropriation shall be taken from the PS savings from various vacant positions for the month of January and February, 2023 as jointly certified by the Municipal Accountant and Municipal Treasurer, and approved by the Municipal Mayor, with the total amount of Three Hundred Eighty Two Thousand One Hundred Ninety Two Pesos and Twenty Five Centavos (P382,192.25).
