APPROPRIATION ORDINANCE NO. 04-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) FROM THE APPROPRIATION CONSTRUCTION OF ONE UNIT COMFORT ROOM AND REPAIR OF COMFORT ROOM AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, PER AO 05-2023, AND TEN THOUSAND PESOS (P10,000.00) FROM THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN OFFICE CAPITAL OUTLAY, A TOTAL OF ONE HUNDRED SIXTY THOUSAND PESOS (P160,000.00) FOR THE EXTENSION OF LEGISLATIVE BUILDING (4X8M) PHASE I, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for CONSTRUCTION OF ONE UNIT COMFORT ROOM AND REPAIR OF COMFORT ROOM AT THE OFFICE OF THE MUNICIPAL VICE MAYOR, PER AO 05-2023, AND TEN THOUSAND PESOS (P10,000.00) FROM THE OFFICE OF THE SECRETARY TO THE SANGGUNIAN OFFICE CAPITAL OUTLAY, A TOTAL OF ONE HUNDRED SIXTY THOUSAND PESOS (P160,000.00);

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
