APPROPRIATION ORDINANCE NO. 04-2025

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO HUNDRED TWENTY ONE THOUSAND PESOS (P221,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – OFFICE EQUIPMENT; REPAIR & MAINTENANCE - AMBULANCE & SAKYANAN NI NANAY; AND MEDICAL SUPPLIES UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO TELEPHONE EXPENSES – MOBILE; INTERNET SUBSCRIPTION EXPENSES; AND PROCUREMENT AND INSTALLATION OF GLASS DOORS AND WINDOWS IN THE MHO MAIN AND AUXILIARY BUILDING OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR AND MAINTENANCE – OFFICE EQUIPMENT; REPAIR & MAINTENANCE - AMBULANCE & SAKYANAN NI NANAY; AND MEDICAL SUPPLIES** under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur;

Section 2. The **TOTAL AMOUNT OF TWO HUNDRED TWENTY - ONE THOUSAND PESOS (P221,000.00)** shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

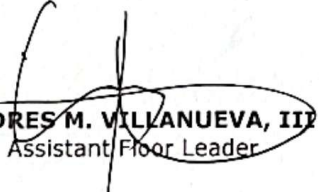

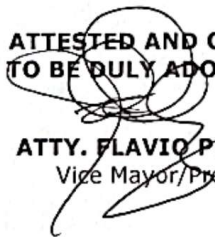
