APPROPRIATION ORDINANCE NO. 05-2024

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. This Appropriation Ordinance shall be entitled "PS Savings of various vacant positions for the month of January and March, 2024."
- **Section 2.** Sources of appropriation shall be taken from the PS savings from various vacant positions for the month of January and March, 2024 as jointly certified by the Municipal Accountant and Municipal Treasurer, and approved by the Municipal Mayor, with the total amount of Six Hundred Sixty-Four Thousand One Hundred Ninety-Three Pesos and Seventy Nine Centavos (**P664,193.79**).

Section 3. The total amount shall be appropriated for the following:
