EXCERPT FROM THE MINUTES OF THE 28TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON MARCH 15, 2023.

APPROPRIATION ORDINANCE NO. 06-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIVE MILLION TWO HUNDRED THOUSAND PESOS (P5,200,000.00) FROM THE APPROPRIATION FOR REPAIR OF CANOPY OF OLD MUNICIPAL BUILDING; PURCHASE OF PIPES, FITTINGS AND ACCESSORIES FOR MUNICIPAL PIPING-GESTI PROJECT; CONSTRUCTION OF COVERED COURT AT MARCOS VILLAGE AND CONCRETING AT MUNICIPAL COMPOUND TO CONSTRUCTION OF WATER TANK (MULTI-PURPOSE BUILDING); CONSTRUCTION OF LEVEL III WATER SYSTEM FOR BARANGAYS PONGAPONG, KAPAMANOK AND OTHERS; AND CONSTRUCTION OF COMPREHENSIVE WELCOME ARCH."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair of Canopy of Old Municipal Building, from General Fund 2021 budget; Purchase of Pipes, Fittings and Accessories for Municipal Piping-GESTI Project, from Gen. Fund 2022 budget; Construction of Covered Court at Marcos Village, from Gen. Fund 2020 budget and Concreting at Municipal Compound from Gen. Fund 2022 budget;

Section 2. The following amount and budget shall be transferred as follows:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

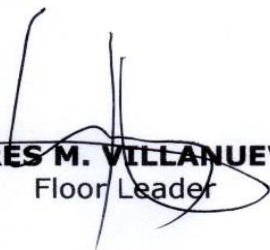

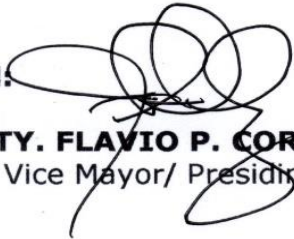
