## **APPROPRIATION ORDINANCE NO. 06-2024**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

- Section 1. This Appropriation Ordinance shall be entitled "SURPLUS OF GENERAL FUND FOR CY 2023."
- **Section 2.** Sources of appropriation shall be taken from the total surplus of the General Fund for CY 2023, as jointly certified by the Municipal Accountant and Municipal Treasurer, and approved by the Municipal Mayor, with the total amount of Twelve Million Pesos (P12,000,000.00).
