APPROPRIATION ORDINANCE NO. 07-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF EIGHTY THOUSAND PESOS (P80,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – AMBULANCE AND SAKYANAN NI NANAY AND GASOLINE, OIL AND LUBRICANTS UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OTHER SUPPLIES AND PRINTING AND BINDING OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance – Ambulance and Sakyanan ni Nanay and Gasoline, Oil and Lubricants under the Office of the Municipal Health Officer, San Pablo, Zamboanga Del Sur, for CY 2023;

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 29TH day of March, 2023, during the 30TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
