APPROPRIATION ORDINANCE NO. 07-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SIXTY-SIX THOUSAND FIVE HUNDRED PESOS (P66,500.00) FROM THE APPROPRIATION FOR PRINTING AND BINDING EXPENSES, DRUGS AND MEDICINE EXPENSES, AND REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO TELEPHONE/MOBILE EXPENSES AND GASOLINE, OIL AND LUBRICANT OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **APPROPRIATION FOR PRINTING AND BINDING EXPENSES, DRUGS AND MEDICINE EXPENSES, AND REPAIR AND MAINTENANCE – AMBULANCE & SAKYANAN NI NANAY** under the office of the Municipal Health Officer, San Pablo, Zamboanga del Sur;

Section 2. The **TOTAL AMOUNT OF SIXTY SIX THOUSAND FIVE HUNDRED PESOS (P66,500.00)** shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
