APPROPRIATION ORDINANCE NO. 08-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF NINETEEN THOUSAND PESOS (P19,000.00) FROM THE APPROPRIATION FOR TELEPHONE EXPENSES – MOBILE, OTHER SUPPLIES EXPENSES, PRINTING AND BINDING EXPENSES, REPAIR AND MAINTENANCE – IT EQUIPMENT & SOFTWARE, OTHER MAINTENANCE & OPERATING EXPENSES AND OTHER SUPPLIES UNDER THE OFFICE OF THE MUNICIPAL CIVIL REGISTRAR TO TRAVELLING EXPENSES AND REPAIR & MAINTENANCE-OFFICE EQUIPMENT OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **TELEPHONE EXPENSES – MOBILE, OTHER SUPPLIES EXPENSES, PRINTING AND BINDING EXPENSES, REPAIR AND MAINTENANCE – IT EQUIPMENT & SOFTWARE, OTHER MAINTENANCE & OPERATING EXPENSES AND OTHER SUPPLIES** under the office of the Municipal Civil Registrar, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **NINETEEN THOUSAND PESOS (P19,000.00)** shall be transferred to wit:

Section 3. Transfer/Augment of Item. Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
