APPROPRIATION ORDINANCE NO. 09-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF ONE HUNDRED FIFTY THOUSAND PESOS (P150,000.00) FROM THE APPROPRIATION FOR CELEBRATION OF INTERNATIONAL YOUTH DAY (LINGGO NG KABATAAN) FOR ALL YOUTH SECTORS AND CONDUCT TRAINING SEMINARS, AND FORUMS ON DRUG ABUSE, UNEMPLOYMENT, AND ORGANIZATIONAL DEVELOPMENT FOR LYDC AND KK MEMBERS, TO PURCHASE OF LAPTOP, AIRCON (INVERTER TYPE), TABLE, CHAIRS AND FRAME DIRECTORY AND SUPPLIES AND MATERIALS FOR THE LOCAL YOUTH DEVELOPMENT OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Education and Social Inclusion and Equity in the Annual Local Youth Development Action Plan and Budget for 2023, under the office of the Local Chief Executive of the San Pablo, Zamboanga Del Sur, amounting Two Hundred Thousand Pesos (P200,000.00) as adopted by the Hon. SB Members per Resolution No. 2022-69;

Section 2. The total amount shall be transferred to wit:

- **Section 3.** Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).
- **Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 12TH day of April, 2023, during the 31ST Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
