APPROPRIATION ORDINANCE NO. 09-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SEVENTY THOUSAND PESOS (P70,000.00) FROM THE APPROPRIATION FOR OFFICE SUPPLIES, PRINTING AND BINDING EXPENSES, OTHER MOOE, AND REPAIR & MAINTENANCE – IT EQUIPMENTS, UNDER THE OFFICE OF THE MUNICIPAL PLANNING & DEVELOPMENT COORDINATOR (MPDC) TO TRAVELLING EXPENSES, REPAIR & MAINTENANCE – OFFICE EQUIPMENTS, AND TELEPHONE EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **APPROPRIATION FOR OFFICE SUPPLIES, PRINTING AND BINDING EXPENSES, OTHER MOOE, AND REPAIR & MAINTENANCE – IT EQUIPMENTS** under the office of the Municipal Planning and Development Coordinator (MPDC), San Pablo, Zamboanga del Sur;

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
