APPROPRIATION ORDINANCE NO. 10-2022

"AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 5 OF SAN PABLO, ZAMBOANGA DEL SUR FOR FISCAL YEAR 2022 IN THE TOTAL AMOUNT OF TWO HUNDRED SEVENTY ONE THOUSAND ONE HUNDRED ONE PESOS AND EIGHTY FOUR CENTAVOS (P271,101.84) COVERING THE VARIOUS EXPENDITURES IN THE LEGISLATIVE OFFICE, AND APPROPRIATING THE NECESSARY FUNDS FOR THE PURPOSE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR, IN SESSION ASSEMBLED:

Section 1. TITLE. This Ordinance shall be entitled **"SUPPLEMENTAL BUDGET NO. 5" of San Pablo, Zamboanga del Sur.**

Section 2. Sources of appropriation shall be taken from the **PS SAVINGS** for the month of July to September, 2022 under the office of the Sangguniang Bayan, San Pablo, Zamboanga del Sur, amounting **Two Hundred Seventy One Thousand One Hundred One Pesos and Eighty Four Centavos (P271,101.84).**

Section 3. The total amount shall be appropriated for the following:
