APPROPRIATION ORDINANCE NO. 11-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY ONE THOUSAND SEVEN HUNDRED SIXTEEN PESOS (P31,716.00) FROM THE APPROPRIATION FOR EQUIPMENT AND SOFTWARE, PRINTING AND BINDING EXPENSES, OFFICE SUPPLIES EXPENSES AND OTHER SUPPLIES EXPENSES UNDER THE OFFICE OF THE MUNICIPAL PLANNING AND DEVELOPMENT COORDINATOR (MPDC), SAN PABLO, ZAMBOANGA DEL SUR, TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Equipment and Software, Printing and Binding Expenses, Office Supplies and Other Supplies Expenses under the Office of the Municipal Planning And Development Coordinator (MPDC), San Pablo, Zamboanga Del Sur, for FY 2022;

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
