APPROPRIATION ORDINANCE NO. 12-2023

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF SIXTY ONE THOUSAND FIVE HUNDRED PESOS (P61,500.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE – AMBULANCE AND SAKYANAN NI NANAY UNDER THE OFFICE OF THE MUNICIPAL HEALTH OFFICER TO OTHER MOOE, PRINTING AND BINDING EXPENSES AND INTERNET SERVICE EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance – Ambulance and Sakyanan ni Nanay under the Office of the Municipal Health Officer, San Pablo, Zamboanga Del Sur, for CY 2023;

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 17TH day of May, 2023, during the 34TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
