APPROPRIATION ORDINANCE NO. 13-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FORTY THREE THOUSAND SIX HUNDRED PESOS (P43,600.00) FROM THE APPROPRIATION FOR OTHER SUPPLIES EXPENSES, TELEPHONE EXPENSES – MOBILE, MEMBERSHIP DUES AND CONTRIBUTION TO ORGANIZATION, REPAIR AND MAINTENANCE – OFFICE EQUIPMENT, REPAIR AND MAINTENANCE – IT EQUIPMENT & SOFTWARE, AND OTHER MOOE UNDER THE OFFICE OF THE MUNICIPAL BUDGET OFFICER, SAN PABLO, ZAMBOANGA DEL SUR TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for OTHER SUPPLIES EXPENSES, TELEPHONE EXPENSES – MOBILE, MEMBERSHIP DUES AND CONTRIBUTION TO ORGANIZATION, REPAIR AND MAINTENANCE – OFFICE EQUIPMENT, REPAIR AND MAINTENANCE - IT EQUIPMENT & SOFTWARE, AND OTHER MOOE under the office of the Municipal Budget Officer, (MBO), San Pablo, Zamboanga del Sur;

Section 2. The total amount of FORTY-THREE THOUSAND SIX HUNDRED PESOS (P43,600.00) shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
