## **APPROPRIATION ORDINANCE NO. 15-2023**

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FOUR HUNDRED TWENTY EIGHT THOUSAND PESOS (P428,000.00) FROM THE APPROPRIATION FOR INSTALLATION OF REBI BEACH RESORT SIGNAGES; REPAIR OF RHU COMFORT ROOM; REPAIR OF PEOPLE'S PARK RAMP; AND REPAIR OF RHU RAMP TO PURCHASE OF OTHER SUPPLIES, REBI BEACH RESORT AND CONSTRUCTION OF PWD COMFORT ROOM UNDER THE OFFICE OF THE MUNICIPAL MAYOR, SAN PABLO, ZAMBOANGA DEL SUR."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for INSTALLATION OF REBI BEACH RESORT SIGNAGES; REPAIR OF RHU COMFORT ROOM; REPAIR OF PEOPLE'S PARK RAMP; AND REPAIR OF RHU RAMP under the Office of the Municipal Mayor, San Pablo, Zamboanga Del Sur;

Section 2. The total amount of FOUR HUNDRED TWENTY EIGHT THOUSAND PESOS (P428,000.00) shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

**Section 4.** Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan, this 21<sup>ST</sup> day of June, 2023, during the 37<sup>H</sup> Regular Session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
