EXCERPT FROM THE MINUTES OF THE 79TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON AUGUST 14, 2024.

APPROPRIATION ORDINANCE NO. 15-2024

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF FIVE THOUSAND FIVE HUNDRED PESOS (P5,500.00) FROM THE APPROPRIATION FOR REPAIR & MAINTENANCE- MOTOR VEHICLES CODE 841 UNDER THE OFFICE OF THE MUNICIPAL VICE MAYOR TO FIDELITY BOND INSURANCE PREMIUM CODE 892 OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIAN BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR & MAINTENANCE- MOTOR VEHICLES CODE 841** under the office of Municipal Vice Mayor, San Pablo, Zamboanga del Sur;

Section 2. The total amount of **FIVE THOUSAND FIVE HUNDRED PESOS (P5,500.00)** shall be transferred to Fidelity Bond Insurance Premium Code 892 of Hon. Vice Mayor, Atty. Flavio P. Cordero, Jr. as signing Officer and Petty Cash Custodian of the Legislative Department.

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.

ENACTED and APPROVED, this 14TH day of August, 2024, during the 79TH Regular session of the Honorable Sangguniang Bayan Members of San Pablo, Zamboanga del Sur.
