APPROPRIATION ORDINANCE NO. 16-2023

“AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWO HUNDRED TWENTY THOUSAND PESOS (P200,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE OF WATER SYSTEM – POBLACION TO REHABILITATION OF ELECTRICAL WIRING OF MUNICIPAL BUILDING, LGU - SAN PABLO, ZAMBOANGA DEL SUR.”

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for **REPAIR AND MAINTENANCE OF WATER SYSTEM – POBLACION** under the Office of the Municipal Mayor, San Pablo, Zamboanga Del Sur, for CY 2023;

Section 2. The total amount of **TWO HUNDRED THOUSAND PESOS (P200,000.00)** shall be transferred to wit:

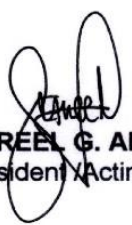

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

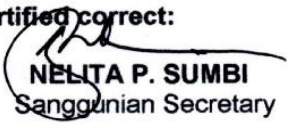

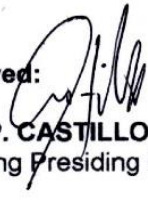
