APPROPRIATION ORDINANCE NO. 18-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY NINE THOUSAND PESOS (P39,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE OF OFFICE EQUIPMENT; REPAIR AND MAINTENANCE OF IT EQUIPMENT; TRAVELLING EXPENSES AND OTHER MOOE UNDER THE OFFICE OF THE WATERWORKS TO REPAIR AND MAINTENANCE OF WATER SYSTEM OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance of Office Equipment; Repair and Maintenance of IT Equipment and travelling Expenses under the office of the Waterworks, San Pablo, Zamboanga del Sur, for CY 2022;

Section 2. The following amount shall be transferred to wit:

Section 3. Transfer/Augment of Item. The Local Chief Executive or the Presiding Officer of the Sanggunian concerned, may by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations, (Art. 454 of RA 7160).

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
