APPROPRIATION ORDINANCE NO. 18-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF THIRTY NINE THOUSAND PESOS (P39,000.00) FROM THE APPROPRIATION FOR REPAIR AND MAINTENANCE OF OFFICE EQUIPMENT; REPAIR AND MAINTENANCE OF IT EQUIPMENT; TRAVELLING EXPENSES AND OTHER MODE UNDER THE OFFICE OF THE WATERWOKS TO REPAIR AND MAINTENANCE OF WATER SYSTEM OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Repair and Maintenance of Office Equipment; Repair and Maintenance of IT Equipment and travelling Expenses under the office of the Waterworks, San Pablo, Zamboanga del Sur, for CY 2022;

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
