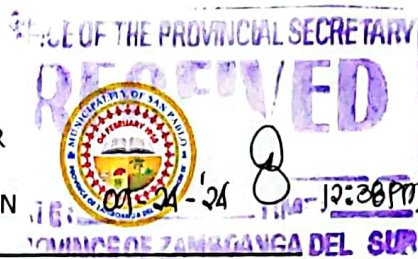

EXCERPT FROM THE MINUTES OF THE 80TH REGULAR SESSION OF THE 11TH MUNICIPAL COUNCIL, HELD AT THE MULTI-PURPOSE BUILDING, SAN PABLO, ZAMBOANGA DEL SUR ON AUGUST 28, 2024.

APPROPRIATION ORDINANCE NO. 18-2024

"AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 2 OF THE MUNICIPALITY OF SAN PABLO, ZAMBOANGA DEL SUR WITH A TOTAL AMOUNT OF FIVE HUNDRED EIGHTY-FIVE THOUSAND NINE HUNDRED THIRTY TWO PESOS AND FIFTY FIVE CENTAVOS (P585,932.55)."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. This appropriation Ordinance shall be entitled Supplemental Budget No. 2 of the General Fund for CY 2024 of San Pablo, Zamboanga del Sur.

Section 2. Sources of Appropriation shall be taken from the PS Savings of the different vacant positions as jointly certified by the Municipal Treasurer, Municipal Accountant and approved by the Hon. Municipal Mayor.

Section 3. The total amount of Five Hundred Eighty-Five Thousand Nine Hundred Thirty-Two Pesos and Fifty-Five Centavos (P585,932.55) shall be appropriated for the following:

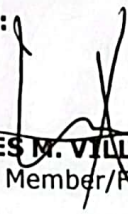
