APPROPRIATION ORDINANCE NO. 20-2022

"AN ORDINANCE TRANSFERRING/AUGMENTING THE TOTAL AMOUNT OF TWENTY FIVE THOUSAND FOUR HUNDRED PESOS (P25,400.00) FROM THE APPROPRIATION FOR TELEPHONE EXPENSES; POSTAGE AND DELIVERIES; PRINTING AND BINDING; REPAIR AND MAINTENANCE OF OFFICE EQUIPMENT AND REPAIR AND MAINTENANCE OF IT EQUIPMENT UNDER THE OFFICE OF THE MUNICIPAL ACCOUNTANT, TO TRAVELLING EXPENSES OF THE SAME OFFICE."

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF SAN PABLO, ZAMBOANGA DEL SUR IN SESSION ASSEMBLED:

Section 1. There is an appropriation for Telephone Expenses; Postage and Deliveries; Printing and Binding; Repair and Maintenance of Office Equipment and Repair and Maintenance of IT Equipment under the Office of the Municipal Accountant, San Pablo, Zamboanga del Sur, for CY 2022;

Section 4. Effectivity. This ordinance shall take effect immediately after approval by the Sangguniang Bayan.
