EXCERPT FROM THE MINUTES OF THE 5TH REGULAR SESSION OF THE 5TH MUNICIPAL COUNCIL OF SAN PABLO, ZAMBOANGA DEL SUR, HELD AT THE SESSION HALL ON June 9, 2010.

RESOLUTION NO. 201006029

WHEREAS, appropriation for the repair and maintenance of heavy equipments is already exhausted due to continuous implementation of various infrastructure projects for this year 2010;

WHEREAS, the Municipal Officials opted to revert the funding for the MSWDO creation of position (lump sum) appropriation as additional funding for the repair and maintenance of heavy equipments in preparation for the rainy season, hence digging of canals and other road maintenance in the different barangays is very necessary.

WHEREFORE, on motion by Hon. Jorge R. Gonzales, severally seconded, be it

RESOLVE, to appropriate as it is hereby appropriated, to ordain as it is hereby ordained:

APPROPRIATION ORDINANCE NO. 10-0605

Section 1. This Appropriation ordinance shall be entitled "Reversion of Appropriation".

Section 2. Sources of appropriation shall be taken from the *MSWDO Creation of Position (Lump Sum appropriation)* amounting Four Hundred Eleven Thousand One Hundred Ninety Pesos (P411,190.00)

Section 3. The total amount of Four Hundred Eleven Thousand One Hundred Ninety Pesos (P411,190.00) shall be reverted for Repair & Maintenance of Heavy Equipment.

Section 3. Amendments to this ordinance shall take effect only when subsequent ordinance shall be enacted by the Sangguniang Bayan of San Pablo, Zamboanga del Sur, amending, supplementing, or repealing any part hereof in line with the established policies, guidelines, laws, rules and regulations enforce.
